





- Condon was right No UFO threat has emerged
- Condon didn't even participate in study
- Condon wrote Conclusions & Recommendations
- Conclusions are inconsistent with body of the report

- Condon Report remains the scientific point of reference

 - No more resources required

COMPARED TO WHAT?:

UFOs are simply *not important* to most people (That is different from whether or not they believe in UFOs)

HOW LARGE INSTITUTIONS WORK






THE APOLLO PROBLEM: WHAT NO ONE SAID!!






PRESIDENTIAL PARADOX 2008

PRIOR TO THE ELECTION I NOTED THAT IF ARV EXISTED IT WOULD BE REVEALED BY 4 NOV 2008

- U.S. & world is in economic crisis
- Polls tightening, but McCain behind
- CEOs of most major corporations favor McCain
- All parties agree energy is critical
- Republicans favor big energy companies
- THEY would have urgent need to insure election
- Incumbents are favored in time of crisis
- McCain seen as more experienced in military matters
- Revelation of ARV/ET would have a threat component
- Revelation of ARV/ET would insure McCain elected

THE LOGIC PROBLEM

- COMPETITION FOR THE MOST POWERFUL POSITION ON EARTH
 - SET THE DIRECTION OF THE WORLD
- CONTROLLED THE INTELLIGENCE COMMUNITY
 - STARTED WARS
 - BUT "THEY" DIDN'T GRANT ACCESS TO:

• THE SECRET

THE QUINTESSENTIAL
OCTOBER SURPRISE

THE TWO PERCENT FACTOR

• I COULD BE WRONG (BUT I DOUBT IT)

• THAT SAID - SEVERAL PEOPLE I HIGHLY RESPECT BELIEVE THERE IS A BLACK UFO PROGRAM

• IN THOSE CASES, THEIR EVIDENCE IS AT LEAST SECONDHAND (IF NOT MORE REMOVED)

• NO SINGLE THEORY ACCOUNTS FOR ALL OF THE EVIDENCE OR OBSERVATIONS

CONCLUSIONS

- UFOs ARE A GLOBAL PHENOMENA
- REALITY IS BEYOND ALL REASONABLE DOUBT
- MASSIVE AMOUNTS OF EVIDENCE SUPPORT UFOS
- DESPITE OVERWHELMING EVIDENCE
 - REALITY IS REJECTED BY MOST SCIENTISTS
 - PUBLIC IS CURIOUS BUT AMBIVALENT
 - MEDIA RIDICULES
- TODAY'S PROBLEMS TAKE PRIORITY
